

IFAN SURVEY AUGUST 2024

The <u>Independent Food Aid Network (IFAN)</u> collated data from frontline member food aid organisations including 149 independent food banks operating across England, Scotland, and Wales in August 2024. The survey found:

- Nearly 69% of organisations responding to the survey had seen increases in need comparing April 2024 July 2024 with the same four-month period last year
- Local authorities and NHS services were the agencies most likely to refer people unable to afford food to food banks
- Nearly 75% of contributing organisations supported people who had been referred or signposted by DWP Jobcentres
- All contributing organisations reported supporting people who had not needed help before
- Three quarters of organisations supported people needing regular help and nearly half were supporting an increased number of people facing extreme hardship
- Nearly 80% of services had seen a drop in food donations while nearly half of the organisations contributing to the survey had seen a drop in financial donations
- Nearly all of the contributing organisations had purchased food to make up for depleted food donations
- If demand were to increase, more than half of contributing organisations said they would need to reduce the size of the food parcels they provided or might not be able to help everyone who asked for support

As <u>IFAN wrote to the Prime Minister on the 5th of July</u>, the new Government has a once in a generation opportunity to reverse the tide of poverty that has swept the country over the past fourteen years

IFAN is calling for immediate, cash first actions to reduce severe food insecurity:

- adoption of <u>an Essentials Guarantee</u> as a first step towards ensuring a <u>Living</u> <u>Income</u> for all
- removal of the two-child limit as well as the benefit cap
- abolition of the sanctions' regime

- removal of the five-week wait for Universal Credit and any benefit deductions
- removal of No Recourse to Public Funds status
- permanent provision of local crisis support funding in England (beyond March 2026) alongside an increase in Local Housing Allowance
- real Living Wages and job security for all
- long-term investment in local advice services
- commencement of section 1 of the Equality Act

Background:

- The <u>Independent Food Aid Network (IFAN)</u> supports and advocates on behalf of charitable food aid providers operating across the UK including hundreds of independent food banks. IFAN's vision is of a country without the need for charitable food aid where adequate and nutritious food is affordable to all.
- A total of 80 organisations running 155 venues, including 74 independent food banks running 149 venues, responded to IFAN's August 2024 survey between the 8th and the 15th of August 2024. - IFAN has identified at least 1,172 independent food banks operating across the UK including those run by multiple faith groups in addition to over 1,300 Trussell Trust food banks as well as hundreds of food banks run by schools, universities, hospitals, and the Salvation Army. There are also thousands of other charitable food aid providers including food pantries, social supermarkets, and soup kitchens.
- IFAN's director, Sabine Goodwin, recently wrote <u>this opinion piece</u> for the Big Issue linked to <u>Trussell's most recent mid-year stats</u> and wider severe food insecurity. According to the most recent <u>Department for Work and Pensions'</u> (<u>DWP</u>) <u>Family Resources Survey (FRS</u>) 86% of households reporting severe food insecurity did not access a food bank.
- IFAN is calling for a cash first approach to food insecurity and has co-produced <u>'Worrying About Money?' cash first referral leaflets</u> in over 130 local authorities in Scotland, England, Wales, and Northern Ireland. These resources help people struggling to afford food and support workers to find local advice and cash first support to maximise income and reduce the need for charitable food aid .
- The DWP's FRS has also found that in the year before the onset of the pandemic, 43% of UK households on Universal Credit were food insecure. Thanks to the £20 weekly increase to Universal Credit, there was a 16% reduction in severe and moderate food insecurity levels for those households relying on this benefit, but the uplift was removed in October 2021.
